(Revenue \$) Teaching Tools for Hillsborough Schools provides critical school supplies year-round for economically disadvantaged students. The program allows teachers from Title 1 schools the opportunity to shop for free school supplies and distribute to their students in need. Teaching Tools serves 140 Title 1 schools and reaches approximately 68,000 at-risk students annually. Each year, local partners, provide over 6,000 hours of volunteer services to the store.

4b (Code:) (Expenses \$ 1,149,946. including grants of \$ 516,384.) (Revenue \$) The Foundation is a provider of statewide Take Stock in Children Program. Through this program over 350 students at poverty level or below along with other risk factors are provided a mentor and the commitment of a college scholarship. Additional scholarships are provided through our community scholarship program, funded by individual and community organizations.

4c (Code:) (Expenses \$ 568,639. including grants of \$ 304,180.) (Revenue \$) Through School Enrichment Grants the Foundation provides funding for schools and teachers to advance learnings through creative and innovative ways. Over 66 projects are funded for school and classroom enrichment programs.
