(Revenue \$) Teaching Tools for Hillsborough Schools provides critical school supplies year-round for economically disadvantaged students. The program allows teachers from Title 1 schools the opportunity to shop for free school supplies and distribute to their students in need. Teaching Tools serves 174 schools and reaches approximately 94,000 at-risk students annually. Each year, local partners, provide over 5,000 hours of volunteer services to the store.

4b (Code:) (Expenses \$ 1,296,781. including grants of \$ 629,582.) (Revenue \$) The Foundation is a provider of the statewide Take Stock in Children Program. Through this program over 350 students at poverty level or below along with other risk factors are provided a mentor and the commitment of a college scholarship. Additional scholarships are provided through our community scholarship program, funded by individual and community organizations.

4c (Code:) (Expenses \$ 592,280. including grants of \$ 489,372.) (Revenue \$) Through School Enrichment Grants the Foundation provides funding for schools and teachers to advance learnings through creative and innovative ways. 78 projects are funded for school and classroom enrichment programs.
