Our Teaching Tools program provides critical school supplies and classroom resources year-round to teachers in all schools. Teaching Tools is a real brick and mortar store primarily stocked through donations of school supplies from individuals and businesses where teachers shop for free school supplies to distribute to students in need. With the help of volunteers who gave over 3,976 hours, Teaching Tools provided support to 3,344 unique teachers in Hillsborough County.

4b (Code:) (Expenses \$ 2,075,850. including grants of \$ 1,461,634.) (Revenue \$)

As an affiliate of the statewide Take Stock in Children program, students at or below poverty level along with other risk factors are provided with a mentor, college readiness coach and the commitment of a college scholarship. During the 2024-2025 school year, 314 students participated in the Take Stock program. For the 2025 senior class, 64 of 65 Take Stock students in the mentoring program graduated and 61 earned their scholarship. These scholarships had a value of over \$521,994. In addition to the TSIC program, HEF also awards community scholarships and 392 students received over \$1.1M in scholarships to pursue post-secondary education.

Through school and classroom enrichment grants the foundation provides funding for schools and teachers to increase their capacity to deliver effective and innovative instructional strategies that enhance and expand learning. The foundation awarded grants to support STEM, literacy, English language arts and other educational areas impacting students at over 110 schools.

- The foundation's Tech Connect program helps to close opportunity gaps and increases access in education for students by providing technology resources for family ownership, access to Wi-Fi, and digital literacy skills training. In 2024-2025, 876 students were served through the program.

- Hillsborough Education Foundation launched its TELI (Transforming Early Literacy Initiative) program in 2023, and now, in its third year, TELI has provided 12,480 hours of coaching and professional development to teachers, with 82% of teachers reporting increased student participation in literacy activities. TELI is designed to improve literacy education in early grade levels, reaching students in a critical time of their educational journey.

- Hillsborough Education Foundation expanded its College and Career Readiness program to five schools, providing 1,464 students with personal guidance and resources to help them plan for life beyond high school. Over 3,200 students were impacted through college visits, career chats and informational workshops, gaining real-world insights into a variety of career paths.
